Principal Duties and Responsibilities (Essential Functions):

- Replaces gaskets, hinges and hardware;
- Adds gas to refrigeration units as needed;
- Checks gauges and makes inspection for preventive maintenance;
- Services refrigerators and freezers;
- Repairs electrical controls, pneumatic and solid state controls;
- Performs trouble shooting and preventive maintenance on all types of heating, air conditioning/refrigeration equipment to determine source of faulty operation;
- Maintains records of repairs and preventive maintenance programs;
- Performs related duties as required.
