Principal Duties and Responsibilities (Essential Functions):

Essential functions are fundamental job duties. They do not include marginal tasks which are also performed but are incidental to the primary functions. - Maintain BICSI Technician certification.
- Connect/Re-Patch Telephone/Data drops.
- Performs related duties as required or assigned.
